

### Facts & Circumstance that support probable cause to arrest the above-named person are

On December 31, 2024, I was contacted by Detective Tiffany Osborne of the Joplin Police Department regarding unauthorized charges to a debit card belonging to the Miracle League of Joplin, which is a non-profit organization that provides children with disabilities the opportunity to play Miracle League baseball in Joplin, Missouri.

Detective Osborne advised her agency was contacted by Miracle League Board Member Shawn Daniel, who detected unauthorized transactions to a debit card (ending in 3280) assigned to the board's treasurer, Aaron Allen Smith. Board Member Shawn Daniel reported the current estimated loss of nearly \$70,000. Of that amount, \$59,316 occurred at Downstream Casino Resort (DCR), located at 69300 East Nee Road in rural Quapaw, Ottawa County, Oklahoma. The transactions occurred between August of 2024 and December of 2024. Additional unauthorized transactions were conducted at Indigo Sky Casino in rural Wyandotte, Oklahoma, the Hardrock Casino in Catoosa, Oklahoma, and at ATMs in Joplin, Missouri, all of which are being investigated in their respective jurisdictions.

Shawn Daniel said the debit card (ending in 3280) was issued to Aaron Smith by the Miracle League of Joplin Board, and stated the account is with US Bank in Joplin, Missouri. The funds in the account are specific to the Miracle League of Joplin expenses and are subject to the board's approval.

Shawn Daniel provided me with bank statements from US Bank dated January 2024-November 2024 for account ending in 2957, which is linked to the debit card ending in 3280. I was also provided statements for accounts ending in 3003 and 9141. On December 18, 2024, Aaron Smith made a \$50,000 deposit into the Miracle League of Joplin account (ending in 2957) from his personal banking account with Commerce Bank in Joplin. On December 19, 2024, the deposit was returned, and the funds were removed from the Miracle League of Joplin's account.

The bank statement for the account ending in 2957 shows the following transactions were made using a debit card ending in 3280 at DCR:

Note: The transactions show the statement date and are listed in order from the most recent transaction. Debit purchases are made through the cashier's cage at DCR and ATM withdrawals are conducted through ATMs, or Ticket Redemption Units (TRUs), on the casino floor at DCR.

I contacted Investigator Damon Von Moss with DCR, who provided me with records from DCR regarding the transactions. Investigator Von Moss provided photos from December 18, 2024, of Aaron Smith arriving at casino alone, driving a Toyota Avalon passenger car bearing Missouri license plate ZC1 H4U. Ottawa County Central Dispatch confirmed the vehicle is registered to Aaron Smith. DCR also provided photographs showing Aaron Smith using an ATM to withdraw money on December 18<sup>th</sup> and December 20<sup>th</sup>, 2024. DCR provided PlayerCash Advantage


documents from the cashier cage, where Aaron Smith provided the debit card ending in 3280 and his driver's license (Missouri J205096008) in order to make cash advances (debit purchases).

Investigator Von Moss also provided Downstream Q Club Player History for Aaron Smith, which shows Aaron Smith used his player's club card in Electronic Gaming Machines (EGMs) during every ATM withdrawal and debit purchase transaction made between September 30, 2024, and December 18, 2024, at DCR. Aaron Smith provided his Missouri driver's license to the DCR Player's Club in order to receive a player's card. The players cards are used in EGMs to track player activity and for patrons to receive points and access to promotional events.

On January 9, 2025, I contacted Aaron Smith by telephone to schedule an interview. Aaron Smith stated he would check his calendar and return my call. I later learned Aaron Smith contacted an attorney. As of January 14, 2025, I have not heard from Aaron Smith or an attorney on his behalf.
